DIRECTIONS FOR USE

IMPORTANT: Before using Bostik T74 High Tack Acrylic Foil Tape, refer to the relevant Health & Safety Data Sheet, available at www.bostik.com/uk.

PREPARATION

 Surfaces to be bonded must be clean, dry and free from dust, grease and loose materials. If necessary, wipe surfaces sparingly with a cloth dampened with a ketone-free cleaner and allow to dry for at least an hour before tape application.

- 2. The butt joints of rigid insulation boards should be positioned together without gaps to ensure an adequate bond. Insulation boards must be mechanically fixed to avoid movement of the boards.
- 3. Select a tape width suitable for the application. A width of 48mm is suitable for closely positioned, flat sections. Otherwise, select a tape the thickness of the insulation plus 50mm to allow for the exposed cut edge.

APPLICATION

4. Remove the release paper from a section of the tape, taking care not to touch the adhesive surface. Align the tape centrally over the joint. Pull the tape taut and then press down well over the entire joint area. Rub the tape to remove any wrinkles or folds.

PRECAUTIONS IN USE

Bostik T74 High Tack Acrylic Foil Tape is intended for joint sealing applications only, and is therefore not suitable for use where the joint is subject to mechanical stress. In this instance, insulation should be fixed using a suitable adhesive or hanger system.
